#### What has been provided?

**Consultation document** - this is the main document to read. It contains background information and diagrams of the proposed routes.

**Frequently Asked Questions** - background information that should be read alongside the consultation document.

**Study Phase 1 Report** - background document that sets out how the scheme objectives were developed.

**Equalities Impact Assessment** - assesses the potential impacts of the project on issues related to equalities.

Also: Indicative diagram of the east and west route options A4174 ring road diagram Constraints diagram Diagram of route options initially considered by the feasibility study

### How will the scheme options be assessed?

Impacts to consider include:

- Traffic volumes and capacity insufficient/no detail provided
- Air quality: not mentioned at all
- Noise: no explanation of noise important areas & not marked on plan
- Water Resources: no details provided impact of eastern options
- Flood Risk: EA information not sourced/provided for eastern options
- Landscape: no detail provided other than reference to 'green belt'
- Ecology: insufficient detail, underestimates impact, biased presentation
- Visual Impacts: insufficient detail, biased presentation
- People and Communities : Option B severe adverse impact
- Cultural Heritage: insufficient detail, underestimate of impact
- Greenhouse gas effects : not mentioned at all

Financial and commercial affordability – could the options be afforded? Who knows? Funding not secured, estimates do not compare like with like.



#### **Doesn't that also include public transport?**


"Public transport, walking and cycling will be considered within scheme option design".












#### How to avoid A4174 to get to M4 from Keynsham





No figures are provided as to the exact levels of traffic flows within the Consultation document: the only figure that is supplied is contained within the FAQ document.....

"The traffic predictions show that on average the 400, 000 journeys will take around 2% less time"

That equates to just 72 seconds per one hour journey!


#### Greater Bristol Strategic Transport Study 2006:


"6.76 Although the new M4 to A4174 Link road scheme has a strong economic case, mainly derived from travel time savings for journeys from outside the study area, it is not being recommended by the study. The new link would alter flow patterns in the congested area between M4 J20 and M4 J19, M32 J1 and the northern stretch of the A4174 Avon Ring Road, putting additional strain on the A4174 and causing congestion problems on the M4 to the east of the new junction with the strong likelihood that the widening of the M4 between Junctions 18A and 18 would be necessary. The improved linkage to the M4 is likely to encourage long-distance commuting to and from developments in Emersons Green and Pucklechurch, which would go against the principles of sustainable development."

#### Map of Bristol Bath Green Belt









Supplementary Planning Document Adopted July 2010 Siston Conservation Area

Supplementary Planning Document Adopted March 2010

Designation provides recognition of the collective value of buildings and their settings and emphasizes the need to protect not just the individual buildings, but the distinctive character of the area as a whole.





#### Some other issues

- Impacts on other infrastructure: Bristol Water and the gas pipe line
- Compulsory Purchase would be required for land AND buildings in the case of Option B
- The EIA makes no allowance for the impact that both Eastern options would have on the Gypsy & Traveller community & safe-guarded sites
- Contradictions between costings estimated at earlier stages of the feasibility study process as evidenced by FOI
- Bias in consultation descriptions and language

## Failings in public engagement

- No attempt has been made to engage with or assess the impact on small business owners prior to consultation
- No attempt has been made by SGC to engage with hard to reach communities
- The public exhibition and its staffing proved to be less than satisfactory
  - just 15% of attendants that provided feedback reported that they were satisfied with what they were told
  - Staff often did not have answers and provided opinions rather than fact
  - Some answers that were given contradicted each other
  - No record of residents' concerns was made SGC only recorded the number of people that attended
  - Many people reported the maps were hard to understand with no landmarks or street names
  - People couldn't identify who they were talking to (SGC or CH2M)

#### Consultation

The dynamic process of dialogue between individuals or groups, based upon a genuine exchange of views, and normally with the objective of influencing decisions, policies or programmes of action.
