2.4. Brief description of your project and what you require S106 funding for

Eagle Crescent has traditional play equipment which is old and outdated having lasted way beyond the expected lifespan of ten to fifteen years. It affords a very poor play experience for the many families around the Oaktree Avenue area.

This level and easy to access play area sits within a residential area making this an ideal site to increase provision for the under 9s allowing supervised play and a place where people can socialise and meet others with children. Census and other data suggests the parish has over 300 youngsters aged 9 and under — the key target age group for this project who could directly benefit from the upgrade (this takes no account of community members who are grandparents (over 19% aged 65+) and may use the playgrounds with grandchildren).

The S106 fundings will enable this valued community space to be improved whilst contributing to improvements to health and well-being:

i) Providing an improved play experience which contributes to stimulating social, physical, creative, emotional and intellectual play to improve children's well-being (South Gloucestershire Council's Play Policy and Strategy 2006 and National Playing Fields Association 2000).

ii) Promoting and encourage health and wellbeing by providing additional play equipment to encourage active play by increasing play options allowing children of different ages, able-bodied or disabled, to come together and play in a variety of different ways (South Gloucestershire Council Sustainable Community Strategy 2016:9).

There was a huge increase in the use of play areas during Covid-19 when the council undertook a play area consultation.

Key findings from the 2021 report (1) highlighted: Limited play value of much of the outdated play equipment (2) with not much for younger children, and more equipment and seating needed. This project affords the opportunities to provide:

- i) A more easily accessible play area for the disabled and for those with pushchairs helps promote equality and community cohesion (SGC 2016:8) (3).
- ii) A more inclusive welcoming social space so parents, carers and other can meet or come together contributes to local pride and a sense of place (SGC 2016:6) and strong community identity (PPC 2011).
- iii) An improved play experience encouraging stimulating social, physical, creative, emotional and intellectual play (SGC's Play Policy and Strategy 2006).
- iv) Opportunities for active play allowing children of different ages and abilities to come together and play in a variety of different ways (SGC Sustainable Community Strategy 2016:9).

It is unlikely but the play area does sit within a residential area. Currently users and residents co-exist without conflict and the proposal is improving an existing long-standing play provision with new equipment suitable for supervised play for the under 9's day time use. There will be engagement with local residents and the wider community throughout the project. Care has been taken to ensure the proposal does nothing to encourage louder activities or attract unsupervised teenagers.

The community consultation on play provision revealed high community expectation for any new equipment, many referencing play areas costing hundreds of thousands of pounds. It is important that any improvements to Eagle Crescent are meaningful, widen participation and improve the play experience. After careful considerations Pucklechurch Parish Council resolved that the initial capital funding allocation available is insufficient to provide the necessary improvements and meet the community's expectations. It wishes to vire maintenance monies across to provide sufficient funding to make a material difference. Pucklechurch Parish Council will fund any shortfall from general reserves and commits to undertaking all future maintenance associated with the play area above the allocation of £17,253.09
